Eric Seib gave maintenance report, pavers complete on south commerce street, inmates working on livestock market, maintenance guys installed flush valve on Hwy 4 Joe Jones, Flush program resulted in no calls, ordered 3 push mowers, will look at zero turn mowers, cast iron pipe workshop, we met with a company to discuss ice pigging, waiting on quote.
