WHEREAS: the gross taxable value for operating purpose not exempt from taxation within Santa Rosa County has been certified by the County Property Appraiser to the Town of Jay as \$42,692,017.00

NOW THEREFORE, BE IT RESOLVED by the Town of Jay, Santa Rosa County Florida that:


1. The FY 2021-2022 operating mileage rate is 3.8000 mills, which is greater than the rolled back rate of 2.6658 mills by 42.55%.
